

# Textbook Affordability Subcommittee Meeting Minutes for 25 October 2022, 12:30-1:30pm Faculty Teaching and Learning Center and Lounge (FTLCL; 9-154) and via [Zoom](#)

- I. Introductions (5 minutes; Information)
- II. District-wide Updates from the Textbook Affordability Solutions Workgroup (5 minutes, Information)
  - a. Talked with VC McVean about how future funding of OER/ZTC work will work with the announcement of the passing of SB 893, which allows SMCCCD to promote the Free Community College Initiative. (OER/ZTC work got funding in the District's AY21-22 budget for 3 years; we're currently in year 2 of that funding.) VC McVean is committed to OER/ZTC being a pillar of the 'Free College' experience, and is pledging to work with us to ensure that there is continued funding of this work at the local level. This will help us once any grant funding is exhausted.
  - b. We should hear soon about the Open Textbook Pilot Project (OTPP) federal grant that the District applied for over the past summer. Our proposal was to create a General Education Zero-Cost Pathway. If approved, it would work in conjunction with the state funding that we will be receiving. Sarah hopes to have an update at next month's TAS meeting.
  - c. Sarah is working with Ame Maloney at Skyline on the XB-12 coding that the State Chancellor's Office is asking us to implement. The idea would be to add the zero-cost pathways as 'cohorts' in Banner. This would make coding easier, which makes PRIE's life easier when they have to run data. It would also play out well with the update to Banner 9, meaning students and the public could search for these pathways easier. More updates to come next month.
- III. CCCC Zero-Textbook-Cost Grants Update (5 minutes; Information)
  - a. Still no word on when Phase 2 will open up.
- IV. Cañada's Plan for CCCC Grants, continued (20 minutes; Discussion)
  - a. COMM has been identified as a zero-cost pathway that could be quickly implemented, and once Phase 2 opens up, we'll apply for that.
  - b. GE pathway is also being identified—we are close, and the COMM courses will help us close gaps nicely. That could be something for Phase 3 or 2
  - c. Sarah is working with Gloria Darafshi, our Articulation Officer, with respect to the GE zero-cost pathway, making sure that the courses will be applicable to the upcoming Cal-GETC GE list. (See attached document that David shared.)
  - d. Sarah is looking to make strong connections with the Science and Technology Division, given that their courses frequently have different needs. Nada and Diane reported that looking at the introductory courses should be a key area of focus, given that there are plenty of resources out there for both textbooks and homework platforms. (Sadly, lab kits don't count as a course material, per the state's definition.)
  - e. Candice mentioned the need to get better marketing of courses, like in the PDF version of the schedule (see [West Valley's example](#)) as well as in an easy-to-understand website (see [West Valley's example](#)). Sarah will reach out to our Marketing folks to get something ready for Summer/Fall 2023; it's a bit late to do Spring 2023, but we could do a minor push.

## Student Transfer Achievement Reform Act of 2021

1. Single GE Pattern for Transfer to CSU and UC – *CalGETC*
  - a. *CalGETC* 2025 – 2026 Catalog Rights
    - i. CCC GE Pattern will change in alignment with *CalGETC*
    - ii. New Bachelor's Degree GE Pathway
2. Automatically place students on ADT pathways, where ADTs for major Pathways exist. by December 31, 2023
3. New unit threshold for STEM ADTs, no more than 6 additional units (total units 66).
