Student Life and Leadership Office - update

November was a busy month for the Student Life and Leadership office. ASCC held 3 events (Halloween Bash, Friendsgiving and Winter Ball) - all of which were centered around engaging and celebrating students. ASCC, in collaboration with the Multicultural Center also hosted a presentation by Professor Noonan on the "History of the Middle East," so that students and community can have stronger understanding and awareness of this region of the world. ASCC also had its winter leadership retreat - where we unpacked what it means to decolonialize and challenge white supremist characteristics as leaders; as well in our own leadership frameworks and ideologies. FAFSA Simplification Act

For a few months now we have been talking in ESC about the need to do a Banner upgrade to support various projects, the impending FAFSA Simplification Act being one of them. Unfortunately, the Department of Education which oversees Federal Financial Aid has been pushing the limits to when they will release the technical information for the ISIR import so that schools can set-up their Student Information Systems,

January 5th-7th: Banner upgrade. Banner and WebSMART unavailable. January 5th is a Friday that we hope we don't have to use as part of the upgrade, but we need a safety day just in case it's more complex than expected. Once we have all of the Banner upgrade packages, the ITS Team will spend time running through the upgrade in a test environment in preparation for this upgrade weekend move to production. (Besides the student upgrades we all think about, anything related to the HR/Finance side and end of year processing is also included in the upgrade, i.e. W2s and 1098Ts for taxes).

January 11th: First Financial Aid checks go out.

January 16th: First Day of school.

please avoid the January 5-7 weekend and possibly look at the January 12-14 weekend if you're looking at these types of events.

The 2024-25 FAFSA will open on 12/31/2023. The reason why it is opening later than expected is due to the changes to the process. The FAFSA Simplification Act has changed many elements from the application that includes, but not limited to,

- Answering no more than 36 questions (previously it was over 100 questions)
- "Expected family contribution" (EFC) will now be called, "student aid index" (SAI), as this will help reduce the confusion about the EFC.
- Expand Pell Grant eligibility to students and families
- Reducing barriers to obtain aid for students and families.

The District is currently working on a website dedicated to the FAFSA Simplification that should be ready after the winter break. The website will have current and new updates about the FAFSA, and will be shared to the campus community.
